8 Whereas, employees of The Associated Students of the University of Montana (ASUM) are
9 bound by ASUM Personnel Policy;

10
11 Whereas, the ASUM Personnel Policy outlines pay scales and job descriptions for the majority
12 of ASUM student employees;

13
14 Whereas, the ASUM Senate voted to decrease the Student Resolution Officer's (SRO) hours
15 from 80 per month to 60 per month in September of 2015;

16
17 Whereas, this was done to reflect the time that the SRO supposedly worked at the time;

18
19 Whereas, the realistic time commitment for the position is 40 hours per month;

20
21 Whereas, this change would save the ASUM Senate \$2172 per year;

22
23 Whereas, the SRO is currently paid at minimum wage plus \$1.00;

25 Whereas, to effectively attract qualified candidates, the ASUM Senate might consider raising the
26 base pay, rather than the base hours;

27
28 Therefore, Let It Be Resolved that the ASUM SRO base hours will decrease from 60 hours per
29 month to 40 hours per month;

30
31 Therefore, Let It Further Be Resolved, that this change will go into effect starting at Fiscal Year
32 2017 (FY17);

33
34 Therefore, Let It Further Be Resolved, that any relevant section of ASUM Personnel Policy be
35 amended immediately to reflect these changes;
