The minutes of the previous meeting were read and corrected & approved.

Moved that [a student entering after the first week, must obtain the signatures of the various instructors ^{whose courses} ~~(under whose)~~ he desires ^{to take} (work), and that his admission should be under the jurisdiction of the Committee on Registration] - 2^d Carried.

Moved that the President be authorized to appoint a Committee ^{in Programing} - 2^d Carried.

The President appointed: Prof. Aber, Reiley, Book, Craig Hill, Harknis.

Moved that the President appoint a Com. of 3 to consider and formulate plans, to draft resolutions regarding Athletics, and to report at the next meeting. - 2^d Carried.

Moved that it be the sense of the Faculty to adhere to the definition of amateur as given in the Constitution of the Mountain Intercol. Association prior to April 1908. - 2^d Carried.

Moved that it be the sense of the Faculty, that [our teams may compete with teams outside the state, that substantially agree with our rules.] - 2^d Carried.

Moved that [Institutions be notified that no correspondence relating to athletic and other events, under the jurisdiction of the A. S. U. M. will be considered binding, unless written by or countersigned by the chairman of these respective committees.] - 2^d Carried.

Moved to consider the question of professional coaching. - 2^d

Moved to adjourn to meet Friday 3³⁰ P.M.
