8       Whereas, The Associated Students of the University of Montana (ASUM) is bound by its Fiscal  
9       Policy;

10  
11       Whereas, Section 9.4 “Budget Request Form and Budgeting Packet” currently reads as follows:

12               *The Business Manager shall prepare a budget request form and a comprehensive packet*  
13       *explaining the budget process including a timeline and include a student group volunteer hour*  
14       *survey made by the Office for Civic Engagement. The budget request form, packet, and survey*  
15       *shall be available until Student Forum as designated in ITEM 9.6. The survey is a non-*  
16       *mandatory form, but shall be taken at the ASUM office with the other forms and delivered to the*  
17       *Office for Civic Engagement no less than once a semester, or upon request.*

19       Whereas, the Office for Civic Engagement (OCE) is no longer in coordination with ASUM to  
20       gather this survey information;

21  
22       Whereas, this section was originally amended to include the segments about the Office for Civic  
23       Engagement in order to gather more student volunteer survey data;

24  
25       Whereas, the gathering of student volunteering data is no longer a campus-wide priority;

26  
27       Whereas, the “Student Forum” also has proposed alterations, including a name change to  
28       “Mandatory Student Group Budgeting Information Session”

29  
30       Therefore, Let It Be Resolved, that Section 9.4 of ASUM Fiscal Policy be amended to read as  
31       follows:

32               *The Business Manager shall prepare a budget request form and a comprehensive packet*  
33       *explaining the budget. The budget request form and packet shall be available until the Student*  
34       *Group Budgeting Information Session as designated in Section 9.6.*
