8 Whereas, the Student Political Action Committee (SPA) is bound by Article IV, Section F of the
9 Associated Students of the University of Montana (ASUM) Bylaws;

10
11 Whereas, Section IV, Subsection F, Part A of the ASUM Bylaws currently reads:

- 12 *a. The Student Political Action Committee shall consist of eleven (11) members, of whom*
13 *five (5) shall be members of the ASUM Senate and five (5) shall be comprised of students-*
14 *at-large and volunteer interns. An additional seat shall be reserved for the SPA Director;*

16 Whereas, an increase in members would benefit SPA in consistently maintaining quorum and
17 attending to general duties;

18
19 Therefore, Let it Be Resolved, That Section IV, Subsection F, Part A of the ASUM Bylaws be
20 amended to read as follows:

- 21 *a. The Student Political Action Committee shall consist of ~~eleven (11)~~ **fourteen (14)***
22 *members, of whom five (5) shall be members of the ASUM Senate and ~~five (5)~~ **eight (8)***
23 *shall be comprised of students-at-large, **senators**, or volunteer interns. An additional seat*
24 *shall be reserved for the SPA Director.*
