

that the A. S. U. M. have power to act in the matter. The amendment was lost, and the original motion was unanimously adopted.

Professor Elrod, chairman of the Committee on Student Affairs, stated that the committee had approved the constitution of the Engineers' Club, which was filed in accordance with the Faculty ruling.

December 13, 1909.

The Faculty met on the call of the President at 4:10 P. M.

Absent: Buckhouse, Dana, Rhodes and Whitaker.

The minutes of the previous meeting were read and approved.

The Committee on Student Affairs recommended that the

following Faculty rule be repealed:

"All student societies and organizations connected with the University are formed subject to the control of the President and Faculty. Copies of the constitutions of all such organizations and all amendments thereto must be filed in the President's office",

and that the following rule be adopted in substitution:

"The organization and continuance of student societies of every description are subject to the approval of the President and Faculty".

Moved by Book and seconded by Rowe that the recommendation of the committee be adopted. The motion was unanimously adopted.

The President announced that it seemed best that department requisitions, chargeable to the appropriations of the current year, must be filed in the office on or before the first day of February, in order that all bills might be audited before the first of March.


The President announced that instructors should observe carefully the rule regarding the withdrawal of students from

classes, - that no dropping of subjects should be permitted without the usual written consent of the Committee on Admission and Registration.

Professor Richter presented a schedule of classes of the engineering department for the 2nd semester, and on motion of Rowe, seconded by Carey, the schedule was referred to the Committee on Examinations and Schedule. *Schedule*

There being no further business before the Faculty, on motion, the meeting adjourned.

The Faculty met on the call of the President at 4:10 P. M.

Absent: Scheuch, Smith and Whitaker.


The minutes of the previous meeting were read and approved.

The President announced that arrangements had been made for an informal at home for students in the Short Course in Forestry, to be held in Woman's Hall, Saturday evening, Jan. 8th.

The President brought up the question of the advisability of the University insisting on vaccination by students and members of the Faculty. The concensus of opinion was that vaccination was advisable, but no definite action was taken concerning the matter. *Vaccination*

Moved by Underwood and seconded by Stewart that the petition of DeWitt C. Warren "to substitute one hour's credit in another collegiate subject for the required one hour's credit in Physical Culture during the present academic year" be granted. The motion was unanimously adopted. *#13 Petition D.G. Warren*

On motion the meeting adjourned.
