9 Whereas, The Associated Students of the University of Montana (ASUM) is the representative
10 voice for students of the University of Montana (UM);
11

12 Whereas, on December 1st, 2016 Montana Commissioner of Higher Education Clayton Christian
13 sent out a message stating that Royce C. Engstrom would resign as President as of December
14 31st;
15

16 Whereas, the status of Program Prioritization efforts at UM has not been addressed since the
17 announcement of President Engstrom's resignation;
18

19 Whereas, there have been no announcements concerning the ongoing status of the present search
20 for the office of Provost and Vice President for Academic Affairs in context of Engstrom's
21 resignation;

23 Whereas, this leaves open the possibility that the position of Provost and Vice President for
24 Academic Affairs will be filled by an interim for the 2017-2018 Academic Year;
25

26 Whereas, the position of the Provost will closely oversee the process of Program Prioritization
27 and will indefinitely influence its decision making processes;
28

29 Whereas, the current timeline for program prioritization entails a 9-12 month listening period
30 beginning in November, 2016;
31

32 Whereas, multiple changes in leadership and ownership of the Program Prioritization process by
33 the Provost compromises the efficiency, consistency, and integrity of this process;

35 Whereas, it is imperative to the health of UM academics that any decisions about Program
36 Prioritization beyond listening and information gathering be conducted by the next permanent
37 Provost of the University of Montana;

39 Whereas, the search for a permanent Provost and Vice President for Academic Affairs has been
40 suspended;
41

42 Whereas, there is a high risk of losing qualified candidates for the position of Provost and Vice
43 President for Academic Affairs if the search is discontinued or paused beyond the duration of
44 Winter Break;
45

46 Therefore, Let It Be Resolved, that the Associated Students of the University of Montana
47 (ASUM) urges the University of Montana to limit the Program Prioritization process to fact-

48 finding and listening sessions until a permanent Provost and Vice President for Academic Affairs
49 has been selected;

50

51 Therefore, Let it Further Be Resolved that ASUM urges the University of Montana to limit the
52 Program Prioritization Process to fact-finding and listening sessions until students return to
53 campus for Fall Semester 2017, should a permanent Provost and Vice President for Academic
54 Affairs be selected before this time;

55

56 Therefore, Let it Further Be Resolved that ASUM urges the University of Montana to continue
57 the ongoing search for a permanent Provost in the most expeditious and timely fashion possible;

59 Therefore, Let It Further Be Resolved, that a copy of this resolution be sent to: Royce C.
60 Engstrom, President of the University of Montana; Sheila Stearns, Incoming-Interim President of
61 the University Montana; Clayton Christian, Commissioner of Higher Education; Beverly
