### **COURSE DESCRIPTION**

Students will gain an overview of environmental and sustainability focused career paths and meet professionals in the field. Students will review core career planning competencies including conducting informational interviews, connecting with alumni, LinkedIn and online job-searching, developing a professional network, and connecting with local organizations for internships and other opportunities. Students will also be encouraged to connect with on-campus career planning resources, including ELCS. Students will have the opportunity to explore sustainability careers and build their professional network by interacting with sustainability professionals.

**ZOOM & MOODLE:** Given the ongoing COVID-19 pandemic, it is possible that at some point in the semester we may need to go to teaching remotely via Zoom exclusively. Classes will be taught in-person as long as possible, but also will be recorded using Zoom. Each recorded class session will be posted to Moodle, so if you have to miss a class, you can watch it later.
