15   Whereas, The original purpose of this committee has been absorbed by the ASUM Sustainability  
16   Coordinator;

18   Whereas, The ASUM Senate retains oversight over the Community Garden via the budgeting  
19   process of ASUM agencies and the hiring of the ASUM Sustainability Coordinator;

21   Therefore, Let it Be Resolved, That Section 21 of the ASUM Bylaws be stricken, thus removing  
22   ASUM Community Garden Board as an ASUM Committee;

24   Therefore, Let it Further Be Resolved, That the subsequent sections of the ASUM Bylaws be  
25   renumbered to reflect these changes.
