8 Whereas, The University of Montana as of this writing has no outdoor public bulletin
9 boards for campus use;

10
11 Whereas, ASUM passed Resolution SB18 which affirmed the need for public bulletin
12 boards governed by ASUM and stated:

13
14 *Therefore, Let It Be Further Resolved, That ASUM shall introduce a future resolution*
15 *affecting its governing documents to create a maintenance and cleanup schedule for*
16 *all ASUM public bulletin boards now and in the future;*

17
18 Whereas, Facilities Services requires a firm and lasting commitment from ASUM to
19 ensure that cleanup and general maintenance will be maintained by ASUM;

20
21 Whereas, Public bulletin boards also require a set of rules governing conduct of board
22 use in order to ensure the designated purpose of these boards is fulfilled;

23
24 Therefore, Let It Be Resolved, That, in the event that funding for public bulletin boards
25 is properly secured from sources outside the Student Activity Fee, Bylaws Section 31 be
26 created to include the following:

28 *ASUM Public Bulletin Boards*

29
30 *A. ASUM owns and operates Bulletin Boards around campus. These are open to the*
31 *public and will be cleaned and maintained by ASUM on a weekly basis.*

33 *B. Every week, posts that are not visibly dated to the new week will be removed from*
34 *ASUM Public Bulletin Boards. Weekly or requested cleaning will remove postings that*
35 *violate any of the Posting Conduct Rules outlined below during a designated senator's*
36 *office hour. ASUM will also maintain the immediate area around boards for any*
37 *refuse materials that are a direct result of Board use.*

39 *C. The Posting Conduct Rules are as follows:*

- 40 • *Postings must be firmly affixed to the board on all four corners*
41 • *Postings may not cover up or obscure other postings*
42 • *No postings are allowed that violate the state law or university policies.*
43 • *No public posts may be placed in the area designated "ASUM Public Business"*
44 • *No duplicate postings may be posted on a single side of the board*
45 • *Only ASUM may take down posters, and only if they violate the other Conduct*
46 *Rules.*

47 • *Postings removed by ASUM will be disposed of in a sustainable fashion.*
