7 Whereas, The Source no longer exists and ShipEx now oversees and monitors banner placement
8 within the University Center (UC);
9

10 Whereas, Current Article V, Section 3, Subsection f (3) of the ASUM Bylaws reads:

11 *3. University Center: Must be approved by the University Center Administration.*
12 *Banners will be allowed only inside the University Center and must be approved by The*
13 *Source prior to being hung in the UC Atrium and must be compliant with UC policy.*
14 *Passing out flyers or laying flyers on surfaces, such as tables and chairs, is prohibited.*
15 *Posters must be placed according to the following guidelines: only on interior windows*
16 *that have been designated and clearly marked for posterizing; Upon attendance of the first*
17 *window lottery occurring at PM on the night prior to the start of campaigning, each*
18 *Senate Candidate, Executive Candidate Team, and Referenda Item will be assigned at*
19 *least one (1) and no more than two (2) half-pane window areas in the UC;;*

21 Therefore, Let It Be Resolved, That Article V, Section 3, Subsection f (3) of the ASUM Bylaws
22 be amended to read as follows:

23 *3. University Center: Must be approved by the University Center Administration.*
24 *Banners will be allowed only inside the University Center and must be approved by*
25 ***whoever the UC Administration has designated to oversee UC banner placement** prior*
26 *to being hung in the UC Atrium and must be compliant with UC policy. Passing out flyers*
27 *or laying flyers on surfaces, such as tables and chairs, is prohibited. Posters must be*
28 *placed according to the following guidelines: only on interior windows that have been*
29 *designated and clearly marked for posterizing; Upon attendance of the first window lottery*
30 *occurring at PM on the night prior to the start of campaigning, each Senate Candidate,*
31 *Executive Candidate Team, and Referenda Item will be assigned at least one (1) and no*
32 *more than two (2) half-pane window areas in the UC;.*
