7 Whereas, In order to serve on an elected position in the Associated Students of the University of
8 Montana (ASUM), senators and executives must be sworn in by the Dean of Students;

10 Whereas, Article I, Section 1 of the ASUM House Rules currently read:

11 *A. All Executives and Senators shall be duly sworn in, by the Dean of Students or his/her*
12 *designee at the first regularly scheduled Senate meeting, with the following oath: I,*
13 _____, *do solemnly swear that I will faithfully execute the office of President/Vice-*
14 *President/Business Manager/Senator of the Associated Students of The University of*
15 *Montana, and will to the best of my ability, preserve, protect, and defend the rights and*
16 *privileges of the students of The University of Montana, and will responsibly undertake*
17 *all duties necessary to secure these ends.;*

19 Whereas, The University of Montana (UM) no longer has or hires a Dean of Students;
20

21 Whereas, The Dean of Students has been split into two different positions;
22

23 Whereas, The ASUM Faculty Advisor has more interaction with the Senate and is present at all
24 Senate meetings;

26 Therefore, Let It Be Resolved, That Article I, Section 1 of the ASUM House rules be amended to
27 read:

28 *A. All Executives and Senators shall be duly sworn in, by the **ASUM Faculty Advisor** or*
29 ***their** designee at the first regularly scheduled Senate meeting, with the following oath: I,*
30 _____, *do solemnly swear that I will faithfully execute the office of President/Vice-*
31 *President/Business Manager/Senator of the Associated Students of The University of*
32 *Montana, and will to the best of my ability, preserve, protect, and defend the rights and*
33 *privileges of the students of The University of Montana, and will responsibly undertake*
34 *all duties necessary to secure these ends.*
