2 **Resolution Removing ASUM Productions Board from ASUM Bylaws**

7 Whereas, The ASUM Productions Board oversaw ASUM Productions;

9 Whereas, The ASUM Productions Board's composition, duties and functions are outlined in the
10 Associated Students of the University of Montana (ASUM) Bylaws;

12 Whereas, ASUM Productions is no longer in operation;

14 Whereas, Article IV, Section 22 of the ASUM Bylaws reads:

15 *a. The ASUM Productions Board shall be composed of no fewer than five (5) and no greater*
16 *than seven (7) voting members, of which three (3) will be members of the ASUM Senate, and at*
17 *least two (2) will be students-at-large. Non-voting members of the board shall include the ASUM*
18 *Productions Director and the ASUM Productions Advisor. The ASUM Productions Board will*
19 *meet a minimum of once monthly, or as further necessitated for show schedules. Sub-committees*
20 *will be created as deemed necessary by the board with members from the ASUM Productions*
21 *Board.*

- 22 1. *The committee shall be chaired by an ASUM Senator. In the event of a special session, the chair*
23 *is required to notify all members of the board prior to the meeting by email or phone in no less*
24 *than twelve (12) hours. In the absence of a quorum, the chair shall act in its absence to its review.*
25 2. *Quorum shall consist of a simple majority of those members currently holding positions.*
26 3. *Duties and functions of the ASUM Productions Board will include:*
27 1. *Examining the budget of ASUM Productions each spring prior to the ASUM budgeting*
28 *session.*
29 2. *Communicating issues within ASUM Productions to the ASUM Senate when appropriate.*
30 3. *Working in conjunction with the ASUM Productions Director and Advisor on issues*
31 *related to ASUM Productions and its operations.*
32 4. *Participating in all ASUM Productions hiring decisions made outside the scope of the*
33 *ASUM Interview Committee.*
34 5. *General oversight of day-to-day business within ASUM Productions where appropriate.*
35 4. *The ASUM Productions Board, in coordination with the ASUM Productions Director, shall*
36 *present an annual report identifying the achievements and areas of potential growth of the*
37 *administration to reflect current student needs.*
38 5. *The ASUM Productions Board, in coordination with the ASUM Productions Director shall*
39 *present a full evaluation and a specific five-year strategic plan to address identified student needs*
40 *every five (5) years.*

41 Therefore, Let It Be Resolved, That Article IV, Section 22 be struck from the ASUM Bylaws;


