12   documents;

15   upon the University of Montana;

17   Whereas, UM cannot handle being caught with its pants down in another scandal;

19   Whereas, Requiring executives to take monthly drug tests will encourage them to hold

33   Therefore, Let It Be Further Resolved, That a recess be held immediately following the passage  
34   of this resolution;

36   Therefore, Let It Be Further Resolved, That the 2018-2019 ASUM Senate requests that the 2019-  
37   2020 ASUM Senate require the newly elected executives to take monthly drug tests;

39   Therefore, Let It Be Further Resolved, That these drug tests be done in the bathrooms during a  
40   recess of an ASUM meeting.
