7 Whereas, The Associated Students of the University of Montana (ASUM) models trust and
8 transparency among students, faculty, and staff¹;

9
10 Whereas, It is important that the name of each committee, board, council, and agency within
11 ASUM be titled appropriately to reflect the purpose of each group;

12
13 Whereas, The Recycling Oversight Board’s focus has shifted from recycling to zero-waste
14 education, initiatives, and community outreach;

15
16 Whereas, Article V, Section 27 of the ASUM Bylaws currently reads “Section 27. Recycling
17 Oversight Board”;

18
19 Whereas, The current title of “Recycling Oversight Board” no longer reflects the purpose of the
20 Board;

22 Therefore, Let It Be Resolved, That Article V, Section 27 of the ASUM Bylaws be amended to
23 read “Section 27. **Zero-Waste Oversight Board**”;

25 Therefore, Let It Be Further Resolved, That every subsection in Article V, Section 27 of the
26 ASUM Bylaws be renumbered to have subsection start with 27;

27
28 Therefore, Let It Be Further Resolved, That this resolution be sent to Gwen Coon, ASUM Office
29 Manager; Eva Rocke, UM Sustainability Coordinator; and Maddy Jones, ASUM Sustainability
30 Coordinator.
