7                   Whereas, the Associated Students of the University of Montana (ASUM) oversees the Student  
8                   Music Union (SMU);  
9

10                  Whereas, The SMU was previously known as the Music Organization Union (MOU);  
11

12                  Whereas, The acronym “MOU” is more formally known as “memorandum of understanding”;  
13

14                  Whereas, The Senate passed SB23 in October 2019 where SMU’s name was formally changed  
15                  from MOU to SMU in the ASUM Bylaws;  
16

17                  Whereas, Instances of the previous title, “MOU”, in other ASUM governing documents should  
18                  be changed to “SMU” for clarity and consistency;

20                  Whereas, Section 9.7.4 of Fiscal Policy currently reads:

22                                 *9.7.4 Music Organization Union. The MOU will be composed of all ASUM-recognized*  
23                                 *music groups. The MOU shall submit one budget for all clubs being so recognized and*  
24                                 *that budget -along with budgets of each subsidiary organization -shall be submitted to*  
25                                 *the ASUM Business manager one week prior to the executive recommendation;*

27                  Therefore, Let It Be Resolved, That Section 9.7.4 of Fiscal Policy be amended to read:

29                                 *9.7.4 Student Music Union. The SMU will be composed of all ASUM-recognized music*  
30                                 *groups. The SMU shall submit one budget for all clubs being so recognized and that*  
31                                 *budget -along with budgets of each subsidiary organization -shall be submitted to the*  
32                                 *ASUM Business manager one week prior to the executive recommendation;*

34                  Therefore, Let It Be Further Resolved, That this resolution be sent to Gwen Coon, ASUM Office  
35                  Manager; Marlene Hendrickson, ASUM Accountant.
