Professors Leaphart and Platt received the two highest numbers of votes, but neither a majority. A vote was taken in which Professor Leaphart received the majority of votes cast, and he was therefore declared elected.

Il. The faculty proceeded to the election of members of the Budget and Policy Committee. On the nominating ballot Professors Rowe and Severy received the two highest numbers of votes for chairman for a term of one year, but neither a majority. On the vote on the two highest Professor Rowe received a majority of all votes cast, and was therefore declared elected.

^{4.} The Committee on Admission and Graduation, Ames, Chairman, recommended that the following candidates for the Bachelor's degree be graduated with honors, since they were certified by the Registrar as having a "B" average at the beginning of the last quarter of residence and were recommended by the chairmen of their major departments. The recommendation was unanimously approved.

- 5. Dr. Ames, acting for Dean Jesse, presented the report of the Committee
- on Admission and Graduation, Enlarged for Administrative Action. The following exceptions to faculty rules granted during the Spring Quarter, 1937:
- 1. Re: Mayme Kelly. Miss Kelly petitioned to be allowed to offer 48 credits earned by correspondence and extension work instead of the maximum 45 toward graduation. Since some of this work was taken by extension under direct supervision of instructors from the University, the Committee granted her petition.
- 2. Re: Mrs. Effie Ray Pond. Mrs. Pond petitioned to be allowed to count $56\frac{1}{2}$ credits earned by correspondence toward the graduation requirements instead of the maximum allowance of 45. Since Mrs. Pond was warned last summer by the Secretary of the Committee on Admission and Graduation that credits earned above the normal allowance would not count toward a degree, the Committee refused Mrs. Pond's request. However, the Committee stated its willingness to allow $50\frac{1}{2}$ credits earned by correspondence, provided Mrs. Pond completes one additional summer session in residence and earns a minimum of 12 credits during that period. This would give her a total of 77 credits earned in residence at this institution, and would bring her within the requirement in regard to graduates of two-year normal schools and colleges, who wish to finish their work at Montana State University. This decision was unanimous.
- 3. Re: June B. Day. Miss Day petitioned to be allowed to have the "n" in Chemistry 13a cancelled. This request was made in an effort to offset 5 excess credits earned by her in her major field. The Committee was not willing to grant her request concerning the removal of the "n", but they did grant the allowance of 5 excess credits in her major field.
- 6. The Committee on Graduate Study, Bateman, Chairman, reported that the following students were candidates for the Master's degree and recommended that degrees be granted them as follows, with the provision that they complete the requirements for their degrees in accordance with faculty rules. The recommendation was unanimously approved.
