

- (4) Re: Barbara May Johnston (Mrs. George A. Santisteban). Miss Johnston petitioned to be allowed to count toward graduation 5 credits for work earned by correspondence in addition to the 10 credits regularly permitted of the last 45 applied on a degree. Miss Johnston has completed 175 credits at Montana State University. Because Miss Johnston is unable to return to the University for additional work and because her work has been of such high grade, her petition was approved.

On the joint recommendations of the Committee on Budget and Policy and the President, and on motion of Severy seconded by Crowder, the faculty voted unanimously to recommend to the State Board of Education, that the Honorary Degree of Doctor of Laws be conferred on George Herbert Greenwood at the next annual Commencement exercises. (Attention was called to the rule of the State Board of Education concerning release of publicity relative to candidates for honorary degrees).

There being no further business before the faculty the meeting on motion was adjourned.

(1) Lists of publications of any character by members of the staff should be sent to the Librarian, Miss Campbell.


(b) By Professor Ames, Chairman of the Retirement and Insurance Committee and member of the Retirement Committee of the faculties of the University institutions:
