MISSOULA STUDENTS RECEIVE UM SCHOLARSHIPS

Eleven students from **Missoula** have received scholarships from The University of Montana.

Amanda Thompson and Erin O'Reilly, both 2006 graduates of Hellgate High School, each received a \$6,000 Louis V. Dubay Four-Year Renewable Scholarship.

Thompson is the daughter of Mary Pat Thompson of Missoula. Her father Reid Thompson lives in Beijing, China.

O'Reilly plans to major in pre-law at UM. Her parents are Judy and Jerry O'Reilly of Missoula.

Clark Kogan and Matt King each received a \$1,500 Louis V. Dubay Scholarship.

Kogan, a junior at UM in physics, graduated from Sentinel High School in 2003. He is the son of Jerry Kogan of Missoula and Cheryl Beyer, who lives in California.

King is a UM senior in international business and marketing. He is the son of Carl and Maureen King of Missoula.

The scholarships were established from the estate of Dubay, a longtime Missoula resident.

Tahra Cerutti was awarded a \$1,000 Cell One Scholarship. She is a junior in international business. Cerutti graduated from Big Sky High School in 1997. She is the daughter of John and Denise Cerutti of Missoula.

A \$1,000 UM License Plate Scholarship went to Paul Morris, a 2006 graduate of Big Sky High School. Morris is the son of Kim Morris and Gene and Michelle Morris of Missoula.

A portion of the cost to purchase Montana's UM license plates makes the License Plate scholarships possible through the University's general scholarship fund.

Clinton Colwell, a 2006 graduate of Hellgate High School, received two scholarships, a \$300 Rasmus and Mathilde Kjeldsen Scholarship and an \$800 Eugene R. and Louise A. Hunton Memorial Scholarship. He is the son of William and Peggy Colwell of Missoula.

The Kjeldsen scholarship was established in 1996 by family members in memory of their grandparents.

The Hunton's children established the scholarship in 1988 in memory of their parents.

Eugene and Louise Hunton, both graduates of UM, taught school in Montana for 38 years.

A \$1,000 Washington Scholarship for Montanans went to Kendra Gingerich, a UM sophomore majoring in pharmacy. Gingerich is a 2004 graduate of Valley Christian School and the daughter of Dean and Phyllis Gingerich of Missoula.

The scholarship fund was established in 1994 by the Dennis and Phyllis Washington Foundation.

Aurora Quinn, a sophomore in education at UM, received a \$2,600 Marjorie Frost Scholarship. The scholarship was established in 1955 by Frost, who attended UM during 1918-

Bonggoch Tangjaipak of Chanthaburi, Thailand, received a \$1,350 Wade and Olive M. Riechel Scholarship. She is a freshman at UM in business administration.

The scholarship was established in 1953 by Olive Riechel in memory of her husband, a prominent Montana rancher.

A \$1,300 Alan Lee Boyer Memorial Scholarship was awarded to Abbott Jasmin, a UM sophomore in medical technology. Jasmin is the daughter of Margit and Winfried Bruhn of Missoula.

The memorial scholarship was established in 1979 by Mr. and Mrs. Charles Boyer for their son, missing in action in Laos in March 1968 and listed as presumed killed in action in January 1979. Alan Boyer attended UM from 1964 to 1966, when he enlisted in the Army.
