Central Board Minutes  
November 14, 1962

The meeting was called to order by President Ed Whitelaw in the Silver Bow room. The minutes of the previous meeting were corrected as follows on page two: the name Gene Budke should read Gene Buck.

Correspondence

Whitelaw read a letter from the Missoula Civic Symphony Association stating that they were sending 100 tickets to be distributed on a "first come, first served" basis. Whitelaw also read an editorial entitled "Why We Remained Calm" written by Art Buchwald.

Budget and Finance

Browman announced that the Student Union Program was considering the purchase of a poster printing press and would like ASMSU to help purchase, thereby gaining the use of, this machine. The cost, depending on the size of the machine purchased, would range from \$450 to \$630. Dennis asked whether there would be any conflict between the two organizations and whether Student Union would purchase part of our equity in the present Silk Screen process. Browman said that the Silk Screen would still be used and the Student Union, if it so desired, could make arrangements to share its use too. Hassing said that if the new machine proved to be more efficient, it would more than likely pay for itself since the output at the present time is small due to the ordering and printing time involved. Whitelaw said that he felt Jerry Van Sickel should present this idea in person and discuss the arrangements Student Union would be willing to make.

Publications Board

Marge Dightman reported that the committee wished to recommend Sharon Fredrickson for the position of Venture Art Editor. Gene Buck and Jean Kay Ferris were the other applicants for the position. DENNIS MOVED THAT CENTRAL BOARD APPOINT SHARON FREDRICKSON AS VENTHRE ART EDITOR. SECONDED BY ROBINSON. Schwanke asked what the particular merits of this candidate were. Dightman said that she had the highest grade average (3.5) and had done much art work in the way of exhibits, designing book covers, and portfolios. MOTION PASSED UNANIMOUSLY.

Freshman Camp

Co-chairman Jim Anderson reported that 92 freshman attended the camp held the Fri., Sat., and Sunday previous to Orientation Week. One of the early problems was the lack of a sufficient number of cars; furthermore, the Chamber of Commerce neglected to have the gates of the camp open soon enough and the cook was unable to get in. Four faculty speakers--Schuster, Thomas, Snow, and Croes--ASMSU representatives, and a member of Spurs, Bear Paw, and the AWS President were on hand to speak. No financial report is available yet. Anderson's main recommendations were:



to have a smaller, more workable committee; to charter a bus; to choose those persons as Camp Counselors who would be the most responsible; to have the cook and the committee at the camp a day early; and to have the chairmen from Missoula so that they might plan this all summer. Anderson said he felt that this camp does a good deal in the way of acting as a pre-orientation week for the new freshmen but should be closely supervised so that its true value is not overlooked.

#### Traditions Board

Jim Erickson requested that the names of Nancy Thorson and Steve Fenter be removed from the committee and the names of Alan Murphy and Jack Russell be added in their stead. COLE MOVED TO ACCEPT THESE CHANGES. SECONDED BY FULLER. MOTION PASSED (13-0) WITH SCHWANKE ABSTAINING.

#### Special Events

Dennis announced that a profit of \$130 was made on the Grizzly-Bobcat mixer last weekend. DENNIS MOVED THAT \$40 OF THIS PROFIT BE USED TO PUT ON A COLORED MOVIE OF THE GRIZZLY-BOBCAT GAME. SECONDED BY FULLER. Dennis said the \$40 cost was to pay room rental; the movie will be shown Thursday, November 15. MOTION CARRIED (13-0) WITH BROWMAN ABSTAINING.

DENNIS MOVED THAT BOB WILLARD AND MARY FOX BE REMOVED FROM SPECIAL EVENTS COMMITTEE, AND THE NAMES OF PEGGY CONNELL, LINDA LENNINGTON AND STACY SNOR BE ADDED. SECONDED BY ROBINSON, MOTION PASSED UNANIMOUSLY. Dennis noted that Willard had requested to be removed.

#### Travel Co-ordinator

Whitelaw announced that on the recommendation of Mr. Eversole he is appointing Chuck Wentworth as Travel Co-ordinator. Chris Cheetham has resigned from the position which she has held for two years.

#### New Business

DENNIS MOVED THAT CENTRAL BOARD APPROPRIATE \$1 PER MEMBER FOR THE PURCHASE OF CARRYING FOLDERS FOR THE MEMBERS. SECONDED BY BERTELSON. Hassing said that since much of the materials in the Central Board files cannot be taken out of the office due to its scarcity, there would be little point in having folders. MOTION WAS DEFEATED 8-7 BY WHITELAW CASTING A NEGATIVE VOTE TO BREAK THE TIE. HASSING, SCHULTZ, COLE, BROWMAN, SCHWANKE, STONE, AND ROBINSON VOTED AGAINST THE MEASURE. Quoth Ed Whitelaw "We remain an outpost of conservatism."
