4 UM STUDENTS TO BE INTERNS AT '73 STATE LEGISLATURE; 2 ALTERNATES NAMED

Four University of Montana students have been selected for legislative internships to assist elected officials during the 1973 State Legislature, which convenes Jan. 1 in Helena, Dr. Robert E. Eagle, director of the UM Bureau of Government Research, has announce

Recipients of the internships for the 43rd legislative assembly are Torian Donohoe, 20, daughter of Mr. and Mrs. C. Clay Donohoe, Nye; Thomas M. Fitzpatrick, 21, son of Mr. and Mrs. Marcus L. Fitzpatrick, Anaconda; Gregory C. Jergeson, 21, son of Mr. and Mrs. John G. Jergeson, Chinook; and Alan D. Robertson, 20, son of Mr. and Mrs. S. Dean Robertson, Malta.

Alternates selected for the internship program are Bruce E. Nelson, 21, son of Mr. and Mrs. John L. Nelson, <u>Carter</u>, and Sandra Sue Snodgrass, 30, daughter of Mrs. Yvonne Mourer, <u>Newberg</u>, <u>Ore</u>.

Miss Donohoe and Robertson are juniors in political science, Jergeson and Nelson are seniors in political science, Fitzpatrick is a senior in political science and history, and Mrs. Snodgrass is a senior in business administration.

The interns and alternates graduated from the following high schools:

Miss Donohoe, Absarokee High School, 1970; Fitzpatrick, Anaconda Senior High School,

1969; Jergeson, Chinook High School, 1969; Nelson, Fort Benton High School, 1969; Robertson, Malta High School, 1970, and Mrs. Snodgrass, Blue Hill High School, Newberg, Ore., 1960.

Eagle said selection of the interns and alternates was made "on the basis of scholastic achievement, political involvement and demonstrated interest."

"The interns will be assigned to work with senators or representatives on an indivi-

dual basis and they will receive academic credit for their work," he said.

Each of the interns receives about \$600 for participating in the intern program. Funds are provided by legislative, University and other sources through the UM Foundation.
