



#### What does "confidential" mean in Montana?

• Request personal criminal records to be expunged or sealed

 Police departments can refuse to provide records related to officer conduct

## Why does it matter?

Police officers have unparalleled power and influence in their communities

• Expanded authority necessitates expanded transparency

• The effects of policing differ by race

• Montanans care about transparency

## How can we fix it?

California State, Legislature. Senate Bill No. 1421. California State Legislature, 20 Sep. 2018

1) discharge of firearm at person,

2) use of force causing great bodily injury or death

- 3) violent assault by an officer
- 4) sexual assault by an officer
- 5) dishonesty relating to one's official duties.

#### Montana Supreme Court precedent supports this

• Great Falls Tribune v. Cascade County Sheriff,

• Citizens to Recall Whitlock v. Whitlock

• Bozeman Daily Chronicle v. City of Bozeman Police Dept.
