BOWERS, PETTIT TO KEYNOTE WINTER FOUNDATION MEETING JAN. 24-25 AT UNIVERSITY

University of Montana President Richard C. Bowers and Commissioner of Higher Education Lawrence K. Pettit will be keynote speakers at the annual winter meeting of the UM Foundation Board of Trustees Friday and Saturday, Jan. 24-25, in the University Center (UC) at UM.

The trustees will meet from 9 a.m.-4 p.m. Friday and 9 a.m.-noon Saturday in rooms 360 D-E of the UC.

Pettit will discuss "Private Philanthropy in Montana's Higher Education System" at 2:30 p.m. Friday, and Bowers will present his "State of the University" address at 11 a.m. Saturday.

The Hon. George H. Boldt, Tacoma, Wash., Senior U.S. District Judge, Western District of Washington, who is the 1975 Foundation president, will introduce the new Foundation trustees Friday. The new trustees include the Foundation's secretary for 1975, Sherman V. Lohn, Missoula, of the law firm Garlington, Lohn and Robinson. Other new trustees are: Juanita M. Daly, Las Vegas, Nev., and Dorothy R. Powers, Spokane, Wash., who is a feature writer for The Spokesman-Review.

The Foundation "President's Report" will be presented by George W. Martin, Seattle, Wash., of the law firm Martin, Niemi, Burch & Mentele, who is immediate past-president

of the Foundation. Martin will address the trustees at the 9:30 a.m. session Friday. Besides Boldt and Lohn, other 1975 Foundation officers are: Warren F. Vaughan, Billings, president of Security Bank, past-secretary and the 1975 Foundation vice-president,

and Calvin L. Murphy, UM business manager, Foundation treasurer.

The UM Foundation was established as a nonprofit organization in 1950 to encourage and develop educational programs and facilities at UM through private contributions and bequests from UM alumni and friends.

Thomas J. Collins, Missoula, is director of the UM Foundation.
