61 UM LAW GRADUATES TO BE ROBED SUNDAY; COURT CEREMONIES ARE MONDAY IN HELENA

MISSOULA --

The 61 University of Montana law school graduates who will be robed at 10:30 a.m. Sunday, June 15, in the UM Music Recital Hall will be admitted to the Montana Supreme Court and the U.S. District Court during ceremonies in Helena Monday, June 16.

Degrees will be conferred on the law graduates at the 78th Annual UM Commencement ceremonies at 2 p.m. Sunday in the Harry Adams Field House.

Robert E. Sullivan, dean of the UM School of Law, will announce the names of those receiving awards, and UM President Richard C. Bowers will present a brief keynote address during the robing ceremonies. Sullivan and Sandra R. Muckelston, assistant law dean, will bestow commencement hoods on the law graduates.

The invocation and benediction at the robing ceremonies will be presented by the Rev. John B. Wang, an associate professor of foreign languages at UM.

Robing ceremony marshals will be Gardner Cromwell and William F. Crowley, UM law professors. Candidates for law degrees should assemble in the Law Building hallway at 10:15 a.m. Sunday.

On Monday, the admission ceremony to the Montana Supreme Court will be at 11 a.m. at the State Capitol, and the admission ceremony to the U.S. District Court will be at 1:30 p.m. in the Federal Building Courtroom.

At the Montana Supreme Court ceremony, Sullivan will present the graduating class, L. and Atty. Gen. Robert/Woodahl will move for admission to practice of most of the/graduates. Woodahl issued special commissions to the following members of the Montana Bar Association:

J. Grainey; Willis M. McKeon, Malta, who will move for the admission of his son, John C.

The Hon. W. J. Jameson, <u>Billings</u>, senior judge for the U.S. District Court of Montana, will swear-in the new lawyers at the afternoon ceremony.
