31ST ANNUAL MEETING  
OF PHARMACY GROUPS  
SET FOR OCT. 18-19 AT UM

MISSOULA--

The 31st Annual meeting of the American Association of Colleges of Pharmacy (AACCP) and the National Association of Boards of Pharmacy (NABP) will be held at the University of Montana Oct. 18 and 19.

Conference sessions will be in the University Center on the Missoula campus. Pre-registration and a reception will be held at the 4 B's Restaurant, 301 E. Broadway, the evening of Oct. 17 .

Representatives from colleges of pharmacy and boards of pharmacy from Montana, Idaho, Oregon, Washington, Wyoming, Alberta and British Columbia will attend, along with the national president and the executive secretary of the NABP.

Other participants will include Robert H. Henry, U.S. Pharmaconeial Convention, and Charles F. Dahl, representing the American Council on Pharmaceutical Education.

Several college faculty members and boards of pharmacy officials from the member states will present papers or participate in panels during the three business sessions. Representatives of the U.S. Public Health Service and the Bureau of Narcotics and Dangerous Drugs also will be on hand.

Local participants will include Dr. James Law, a Missoula pediatrician, and faculty members of the UM School of Pharmacy--Professors J. L. Wailes, R. J. Bennett, G. H. Bryan, F. A. Pettinato, M. W. Gouda, and V. H. Duke.

## 31ST ANNUAL MEETING OF PHARMACY GROUPS--2

The sessions will consider such topics of current interest to the profession of pharmacy as procedures and rules governing internship in pharmacy, national accrediting procedures for colleges of pharmacy, evaluation of drug products with regard to their clinical effectiveness, new regulations controlling dangerous drugs and narcotics and drug interactions in therapy.

A special report on drug abuse in Britain and Scandinavia will be presented at a noon luncheon Oct. 18 by Dr. Pov Hammerlund, University of Washington College of Pharmacy, who recently returned from a sabbatical leave spent in those countries.

The University's singing Jubileers will entertain following the evening banquet in the University Center Five Valleys Ballroom on Oct. 18. Dr. Joseph A. Mussulman, an associate professor of music at UM, is Jubilee director.

The meetings will adjourn with a noon luncheon on Oct. 19.

Chairman of the Boards of Pharmacy is William J. Fitzgerald of Super Save Drugs in Great Falls. Dr. Robert L. Van Horne, dean of the UM School of Pharmacy and chairman of the AACP, is general program chairman. Next year's meeting is planned for the University of Alberta at Edmonton.
