### DANIEL MCCARTHY RECEIVES FIRST ANDERSON SCHOLARSHIP

#### MISSOULA--

Daniel T. McCarthy, <u>Walkerville</u>, a senior in law at the University of Montana, has been named the first recipient of the one-year James Anderson Memorial Scholarship at the University.

McCarthy, son of Mr. and Mrs. Daniel J. McCarthy, 115 O'Neill St., <u>Walkerville</u>, is a 1968 graduate of Carroll College, <u>Helena</u>. He recently completed a summer internship with Silver Bow County Legal Services, <u>Butte</u>.

McCarthy served in the Army for three years. The Vietnam veteran was awarded three Bronze Stars and two Purple Hearts during his tour of duty.

The Anderson Scholarship was established this year in memory of the late James Anderson, <u>Miles City</u>, a member of the UN School of Law graduating class of 1966 who was killed in the crash of a private plan mear <u>Butte April 17</u>, 1971.

Contributions from Mr. Anderson's classmates are providing the funds for the scholarship. Larry Riley, a Missoula attorney and one of Mr. Anderson's classmates from the class of '66, spearheaded successful efforts to establish the scholarship.

Robert E. Sullivan, dean of the UN School of Law, said the annual award will consist of a full fee scholarship for the academic year. A plaque also will be permanently displayed in the UN Law Building in Mr. Anderson's memory. Names of the annual scholarship recipients will be engraved on the plaque.

Besides the Juris Doctor's degree awarded to him in 1966, Mr. Anderson received his bachelor's degree in history at UM in 1963. He served as a special agent with the Federal Bureau of Investigation following receipt of his law degree. In 1969 he became an assistant to the State Attorney General in Montana.
