27 TEACHERS REPRESENT 17 STATES AT UM SUMMER MATH INSTITUTE

MISSOULA, Mont .--

A total of 27 teachers from 17 states, including six from Montana, recently participated in the 1973 Summer Institute for High School Teachers of Mathematics at the University of Montana, Missoula.

The program, which leads to the Master of Arts degree for math teachers, was sponsored under a \$50,672 grant from the National Science Foundation. Teachers earn their degrees by participating in four summer sessions of study at UM.

Two UM mathematics professors served as coordinators of the program. Dr. William R. Ballard was director and Dr. William M. Myers was associate director of the institute.

This has been the 14th consecutive summer that University faculty have conducted the institute on the Missoula campus.
