GENERAL BOARD MINUTES

May 2, 1944

President Jack Cuthbert called the meeting to order and the minutes of the April 25 meeting were read and approved.

The recommendations of Publications Board were read. Murphy moved to approve the recommendation of the appointment of Karma Johnson as the Editor of the Kaimin for 1944-45. Voldseth seconded, and motion carried.

Voldseth moved to approve the recommendation of the appointment of Marilyn Hillstrand as Business Manager of the Kaimin for 1944-45. Briggs seconded. Motion carried.

Voldseth moved to accept the recommendation of the appointment of Tanisse Brown to the position of Local Advertising Manager of the Kaimin for 1944-45. Dillavou seconded and motion carried.

Dillavou moved that the salary of the Editor of the Kaimin be raised \$5 per month. Voldseth seconded. Motion did not carry.

The suggestion was made to have whoever was in charge of circulation of the Kaimin this year come into Central Board and explain how it was carried on and what was required in the job.

Lorraine Griffith explained why the Publications Board recommended that no Sentinel be put out for 1944-45 because of the difficulty of getting supplies and also of getting photography done down town or by students. She also told about the prospective plan of having a room remodeled and equipped in the Journalism Building for the Sentinel staff in the future. It was brought out that the University through the Journalism School would take over the remodeling, but that perhaps Central Board could appropriate money to the Sentinel to purchase some equipment to be put in the room for future use.

Ed Voldseth read some letters he received from schools regarding deferred rushing. Mrs. Fields, a member of the City Panhellenic Organization, gave her point of view on deferred rushing and it was discussed in general.

Meeting adjourned.
