CENTRAL BOARD
Oct. 17, 1944

Meeting was called to order by the president and the minutes of the previous meeting, Oct. 11, 1944, were read and corrected.

Bakke read and explained the Supplementay Budget for 1944-45 which is attached herewith.

Castle moved the budget be approved as read. Dillavou seconded and the motion carried.

The amendments passed in the two previous meetings, Oct. 3 and 10, will not be submitted to the students in the coming election since Article XI, Section 1 of the Constitution states that proposed amendments may be voted on only in the spring elections. A representative from the A.S.T.R.P. will be asked to come to the Central Board meetings but he will not have the privilege of voting.

The advisability of appointing another member to Convocations Committee for this year was discussed and agreed upon.

Kinkade moved that the membership on Convocation Committee be enlarged to six persons instead of five for this year. Floyd seconded and the motion carried.

Jeffers asked that Central Board appropriate \$498.00 to cover the expense of printing and binding the Mountaineer. This estimate was made by the Missoulian and would include three separate editions of a thousand copies. Each student would receive a copy on presentation of an activity ticket and the remaining copies would be sold at ten or fifteen cents a piece. Previously the magazine has been mimeographed at an approximate cost of \$80.00 for the year.

Castle moved the Mountaineer committee investigate other means of having their publication printed then present their request for an appropriation to the Budget and Finance Committee for their consideration before any appropriation is made through Central Board. Sackett seconded and the motion carried.

Meeting adjourned.
