The first University of Montana College of Arts and Sciences (CAS) Faculty Journal, "This Issue," was recently published by the College under the aegis of Richard A. Solberg, Dean of the College. The theme of the first edition is "The Liberal Arts College: Problems and Prospects."

The journal is designed to provide a forum for the expression of ideas about community and of personal views and experiences in the context of liberal education, Solberg said in the first issue's preface.

Each issue will focus principally on at least one major theme. In addition, matters of particular relevance to the aims, goals and appeal of the College of Arts and Sciences within the total context of the University will be included, Solberg added.

"The Journal is one of the finest collective intellectual and academic efforts to come from this University in recent years," Solberg commented.

Professor Lane C. McGaughy, acting chairman of the Religious Studies Department at UMI, wrote the editorial comment for the first edition of the journal. McGaughy stated that the journal is offered to the UMI faculty as one forum for the participation in a decision-making process in which judgments are based on thorough consideration of the issues.

McGaughy is chairman of the Journal's Editorial Board. Board members include Walter E. Hill, assistant professor of Chemistry; Richard P. Sheridan, assistant professor of Botany, and Maxine Van de Wetering, assistant professor of History and Humanities.

McGaughy said that the editors of the journal stand ready to print constructive contributions and critical responses to any issue of importance to the College of Arts and Sciences.
