\$31,969 IN FINANCIAL AID
AWARDED TO 56 UM LAW STUDENTS

MISSOULA--

A total of \$31,969 in financial aid has been awarded to 56 students at the School of Law, University of Montana, for the 1976-77 academic year, according to Robert E. Sullivan, dean of the law school.

Sullivan said the bulk of the aid was in \$500 scholarships and fee waivers provided by donors from Montana and out-of-state contributors. Six UM law students also received law assistantships of \$1,200 each.

"In a time of increasing costs and increasing need by UM law students, the support provided by the donors of these scholarships is especially noteworthy," Sullivan said, adding that anyone interested in the scholarship program may contact the UM law school.
