Course Objective: Students will gain an appreciation and an understanding of the tools and methodologies used in set and prop construction.

Course Description: Scenery Construction is a course designed to develop skills and knowledge of pertaining scenery construction for the stage through practical hands on application. Utilizing the various tools the designer has given us, mainly draftings and models, we are responsible for building and painting scenery and props for the stage, while striving to maintain the highest integrity of the designer's artistic vision.

Required Materials: Tape Measure (25'), Pencils, Safety Glasses (ANSI Z87.1-2003)

Course Requirements:

Two scheduled production strikes, active/meaningful participation during class hours, all TBA weekend work calls, demonstrated advancement in scenery construction knowledge and skill, demonstrated advancement in scene shop protocol and safety, tool usage, tool safety.

Grading:

Theatre is a collaborative art. Everyone involved serves as an integral part of the production as a whole. Though, we may not be on stage performing, our craftsmanship is a vital aspect of every performance. Therefore, simply being present for class and strikes does not constitute an "A." Each class member will be assessed on willingness to work, preparedness for each class, retention of training, readiness to help classmates, attention to safety, respect for equipment, and progress in basic scenic construction skills. Final grade will be a result of the combination of three separate aspects of the class. Attendance hours constitute $\frac{1}{4}$ of the final grade, demonstrated skill and knowledge assessment will be $\frac{1}{2}$ of the final grade and strike participation will count as $\frac{1}{4}$ of the final grade.

Benchmarks:

Though there are no written assignments in the scene shop, there are multiple benchmarks that I will look for during assessment.

At MIDTERM:

- Identify essential tools, hardware and fasteners.
- Confident knowledge of scene shop, tool room and other tool storage areas.
- Confident knowledge in the usage of stationary and portable tools.
- Fluent in theatre terminology as it applies to scenery.

At Final Show:

- Continued proficiency in above items
- Demonstrated advancement/retention of basic construction techniques

Policies:

- Please be prepared for every class.
- Dress in a manner appropriate for work in a shop. Oils, dust and paint are common hazards to clothing. Shoes cannot be slip-ons or open-toed. Clothes cannot be extremely baggy or formal. Long hair must be tied back and contained so it does not fall forward; jewelry that may dangle into the moving parts of a tool is prohibited.
- Be ready to *receive instruction* at the top of the scheduled hour.
- Have the required items with you (tape measure, pencil, and safety glasses) and ready to use at the top of the scheduled hour. If you are not fully prepared for class, I reserve the right to release you from any duties for the day, which will prevent you from getting hours for the day.
- Due to safety considerations, at **no** point during a student's time spent in class or serving on a production (in any capacity) should non-enrolled persons be guests of that student without my consent. Presence of such unauthorized persons in a class, shop, or any backstage/off-stage area will negatively affect a student's grade.
- A shop runs most effectively when it is clean and organized. At the end of each day, we will stop working no later than 15 minutes prior to the end of class so everyone can help clean the entire shop.
- You will be required to "clock" in at the start and end of each class. At the end of class everyone will be excused at the same time. Please be considerate to your fellow students and stay until cleanup is complete and the class has been released .

Attendance

Attendance is essential to the completion of each show and also to pass the course. If you know you must be late or absent, please call my office (**243-4511**) or email me to let me know.

Attendance points: counts for unexcused arriving late or leaving early

On time = 5points 1-5 min -1point 10-20 min -2points 20-30 min - 3points

- If you are late or leave early four times it will count as one unexcused day.
- Three unexcused absences will result in drop of one full letter grade for your attendance score

- Each unexcused absence thereafter will result in an additional ½ letter grade drop in attendance score.
