AutoCAD, hand drafting tools as needed, rendering tools as needed

Course Description:

This course is designed to provide graduate students the opportunity to create fully realized and complex drafting and design paperwork for a theatrical production. Students will study page layout, and create all the necessary drafted plates and designer plates for a realized production.

Course Objectives:

This course will give the training and the opportunity for designers and technicians to discover the correct method and complete collection of paperwork, artwork and organization skills to present a fully complete package of materials to a director and a shop. Designers and technical directors will work together to learn what material is necessary and how best to present ideas to one another. Drafting and design packages will be created and shared over the course of the term.

Grading:

This course will consist the creation of a full package of drawings, draftings and designs for a realized production. Grading will be based on thoroughness, accuracy, clarity and aesthetics.

Do not fall behind! This course is rigorous and you will find it very difficult to succeed if you do not stay up to date in your work!

Attendance policy:

Attendance is extremely important; it is assumed students will attend all classes. ***Only two unexcused absences are allowed***, each absence after two will result in the loss of ten points from the student's total points. An unexcused absence is defined by failing to notify the instructor PRIOR to missing a class. Assignments are due either on or prior to due date. Late assignments will be accepted at the discretion of the instructor, and will be marked down a minimum of 10%.
