## BARRISTERS TO HOLD CONVENTION ON SATURDAY

Judges from all over Montana have been invited to the third annual Montana Judges Day, Saturday, April 30, sponsored by the University of Montana Student Bar Association.

Two dinners, several speakers and the traditional Barrister's Ball will highlight the one day gathering.

Following the 12:30 luncheon at the Lodge, the delegates will attend discussions on the legal aid programs in room 203 of the law building. Robert E. Sullivan, Dean of the UM Law School, will introduce the two speakers: William E. Crowley, associate professor of law, UM, and Dexter Delaney, Missoula attorney.

Prof. Crowley will speak on the "Legal Defender Project" under the National Legal Aid and Defender Association. Delaney will discuss "Legal Aid to Indigents" under the office of Economic opportunity.

The speaker at the 6:30 award dinner at the Missoula Country Club, will be Cale J. Crowley of Billings, president of the Montana Bar Association.

Awards will be presented to outstanding UM law students and Crowley will present a plaque to Dr. David R. Mason, Dixon Professor of law.

Dr. Mason, last year was given the first Montana Bar Association award for his work as chairman of an advisory committee that drafted new appellate procedure rules for Montana. The plaque will be in recognition of "an outstanding contribution to the legal profession carried out or completed during the year."

Following the dinner will be the Barrister's Ball, also to be at the country club.
