4-28-66 UM LAW SCHOOL AWARDS
TO BE GIVEN SATURDAY

Nine awards will be presented to outstanding University of Montana law students at the annual Barrister's Ball banquet this Saturday. (April 30)

Speaking at the banquet, to be held at the Missoula Country Club, will be Cale Crowley, president of the Montana Bar Association.

Among the awards to be given are these:

The Lawyers' Title Award; a \$100 award and certificate for excellence in property law work presented by Lawyers' Title Insurance Corporation of Richmond Virginia.

The Rocky Mountain Mineral Law Foundation Scholarship award; a \$200 award to an outstanding junior or senior law student in the field of mineral law.

The Thomas E. Mulroney Memorial Scholarship; a \$150 award in memory of a Missoula attorney to a law student of high character.

The Charles M. Pray Worthy Scholar Award; a \$200 cash bequest in memory of the late Judge Pray for a student with outstanding scholarship despite severe handicaps.

The Albyn F. McCulloh scholarship award; a \$300 stipend which goes annually to one or more Montana residents who are worthy of assistance in gaining a legal education.

President Crowley will present a special award to UM Law School Professor Dr. David R. Mason, the Dixon professor of law. The award is a plaque which was bestowed last year by the Montana Bar Association for Mason's work with an advisory committee which drafted new appellate procedure rules for Montana. The award, first of its kind, lauds Mason's "outstanding contribution to the legal profession."

Saturday will also be Judges Day in Missoula. Judges from all over Montana have been invited to attend the affair. Discussions will be held on legal aid programs, the new legal defender project and legal aid to indigents.

The evening Barrister's Ball will climax the affair.
