

- Journalize transactions involving preferred, common, and treasury stock
- Examine stock and retained earnings transactions including issues, purchases, and dividend.

- Prepare a statement of cash flows.
- Analyze the performance of a business entity using its financial statements.

Course Format and Policies

This course follows the text closely. For each topic covered, you should read the relevant chapter in the text or supplemental readings prior to class. You are expected to do the assigned readings. Some topics that are very important are covered in great detail. In these cases, the readings serve to reinforce what is covered in class. However, time does not allow all topics to be covered in such detail. Therefore, reading is necessary. You are responsible for all material covered in assigned readings whether we have time to cover it in class. Reading ahead is encouraged, as it will aid your understanding of material presented in class. Re-reading after class is also encouraged, as it will help solidify the concepts just presented. If you read information that is not covered in class, and you do not understand it, I will be happy to work it through with you during office hours.

To be sure, this course is fast-paced and demanding. A significant amount of time outside of class is required in order to master the material, both before class in preparation for class discussions and in the completion of the work assigned. You are responsible for reviewing the assigned material before class and are expected to participate in class discussion.

<u>CNow Quizzes</u>: After reading each chapter and lecture, you will be asked to complete a quiz. We MAY spend time in class working on these guizzes. These guizzes are not timed, you have 1 attempt, and one check-my-work.

<u>CNow Homework:</u> There are assignments for each chapter. These assignments are not timed, you have 1 attempt, and

one check-my-work. The CNow Homework Manager is a Web-based tool for submission of homework and includes automated grading for end-of-chapter assigned problems.

Attendance. Regular and <u>engaged</u> attendance is necessary in order to successfully complete the course and this aspect of a student's involvement in the course will be considered in awarding the grade. If you arrive late for class, you will be deemed absent for the day. If you are unable to attend class, for any reason, it is your responsibility to contact a member of the class for an update. You do not need to contact me unless the period of absence exceeds 2 consecutive class meetings. During the course, you can miss up to 3 class periods without reducing your attendance grade. Subsequently, each absence will result in a 5% reduction from your average.

Test Policy. Students are expected to take exams at their regular scheduled time unless they have an excused absence. Excused absences include 1) University related, 2) documented health emergencies, 3) civil service, 4) other exigent circumstances. In all cases, you must notify me prior to the exam unless the emergency makes that impossible. You must make up the exam the day you return to school.

There is an expectation of professionalism in your conduct in the classroom as well as all work submitted: 1) Courtesy, timeliness, and respectful communication are expected; 2) Spelling and grammar are expected to be appropriate for college students; 3) Classes begin and end on time. It is very distracting to the whole class and to me to have students arrive late, leave early, or come in and out during the class session. Please plan your schedule so you are not a source of this distraction; 4) Come prepared with all materials needed for class. If you are not on camera with the microphone available, you are considered NOT PRESENT. 5) Adhere to the policy regarding the use of personal electronic devices (see below)
