**Introduction:**

Prerequisite: MUSI 105 and MUSI 140; Co-requisite: MUSI 141. Theory II is a continuation of MUSI 105 (Theory I). This course is designed as an introductory study of 18<sup>th</sup>-century contrapuntal and harmonic materials, along with an overview of structures of music as defined by and expressed in the Western European historical traditions of the *common practice period*.

This course is designed to guide students toward an understanding and application of the common elements and organizational patterns of music and their interaction, an ability to employ this understanding in verbal and visual analyses, and to aid in the development of aural skills. Central to theoretical understanding is application of writing principles in two-, three-, and four-part composition, supplemented with introductory experiences in piano.
