## TWENTY COMPLETE FCC LICENSE COURSE AT UNIVERSITY OF MONTANA

MISSOULA --

Twenty Montanans have completed the first course offered in the state for the Federal Communications Commission first class license.

Sponsored by the Montana Broadcasters Association, the course was conducted at the University of Montana by Richard G. Kingsolver, the coordinator of electronics at Casper College, Casper, Wyo.

The students paid \$200 for the course which began June 19. Kingsolver said they studied material that normally is presented during a 1½ year period at the Wyoming school.
