Fourteen University of Montana law students received various awards Saturday night (April 20) during the Barrister's Banquet, held in conjunction with the University's annual Law Weekend.

The banquet and Barrister's Ball were held in the Florence Hotel in Missoula, highlighting Law Weekend activities both on and off campus.

K. Dale Schwanke, Missoula, was named recipient of four awards. He received selected law books from the American Law Book Co. for being the third-year law student at UM who made the most significant contribution toward over all legal scholarship. First-year winner of a similar award was Kenneth D. Tolliver, <u>Billings</u>, and second-year winner was Laurence E. Eck, <u>Bozeman</u>.

Schwanke also was named winner of a year's subscription to the Wall Street Journal and an inscribed medallion as graduating senior receiving the highest grade/ in business organizations.

Schwanke also won the Prentice-Hall Tax Award and will receive the Prentice-Hall Federal Tax Guide with weekly supplementations as the graduating senior receiving the highest grade in two federal tax courses at the University. He received a certificate of excellence as one of eight law students to be graduated with honors.
