Three faculty members and nine students at the University of Montana (UM) were honored at a luncheon Tuesday in the UM Lodge as new members of Beta Gamma Sigma (BGS), the national scholastic honorary society of accredited business administration schools.

Faculty members named to membership in the Alpha of Montana Chapter of BGS are Dr. Glenn R. Barth, associate professor of business administration; Mrs. Maxine C. Johnson, assistant professor of business administration and assistant director of the Bureau of Business and Economic Research, and Dr. Thomas G. Johnson, professor of business administration and chairman of the UM Department of Management.

Students elected to membership in BGS include Patricia L. Nolan, Robert A. Fredrickson and Conrad J. Hanson, Missoula; George A. Redding, Butte; John S. Monger, Dillon; Kathleen M. Spall, Great Falls; Betty J. Clenin, Billings; Gary L. Kaiser, Hardin, and Marvin M. Galts, Lethbridge, Alberta, Canada.

Student requirements for election to membership in BGS are a year in residence at UM, a grade point average of 3.5 on 4.0 basis for graduate students and 3.2 for undergraduate

students. Faculty members are eligible for membership after two years at the University.

Mrs. Johnson received her bachelor's degree from Washington State University and her master's from UM. She is a member of Phi Beta Kappa, national scholastic honorary.

Dr. Johnson received his bachelor's degree from the University of Illinois, his master's from the University of North Dakota (UND), and his doctorate from the University of Chicago.

Dr. Barth was awarded his bachelor's degree at UND, his master's at the University of Minnesota and his doctorate from Montana State University, Bozeman.
