18 UM FOUNDATION TRUSTEES TO ATTEND SUMMER MEETING

Eighteen members of the Board of Trustees of the University of Montana Foundation will be among those attending the Foundation's annual summer meeting Thursday and Friday (July 25-26).

The two-day meeting, to begin Thursday morning in the UM Lodge and moved Thursday afternoon to the Lubrecht Experimental Forest, 30 miles northeast of Missoula, will be highlighted by the "State of the University Address " by UM President Robert T. Pantzer.
