36 STATE, FEDERAL
EMPLOYES PREREGISTER
FOR UM LEADERSHIP CLASSES

MISSOULA, Mont.---

Second session of the 24th annual School for Administrative Leadership (SAL) at the University of Montana begins Monday (Feb. 3) and continues through Feb. 28, with 36 state and federal employes already registered for classes.

Representatives of the U.S. Forest Service (USFS), Bureau of Indian Affairs (BIA), National Park Service (NPS), State Forester's Office (SFO) and the State Fish and Game Commission (SFGC) are among the three-dozen government representatives slated to attend the four-week leadership program.

Participants meet at 8 a.m. Monday for a three-hour orientation program in the new University Center (UC). Eight UM faculty members will teach classes during the four-week program, covering areas such as public, community and human relations, economics, public administration, effective writing, political interest groups and public policy, and administrative communication.

SAL instructors at UM this year include Edward B. Dugan, journalism professor; Dr. Gordon Browder, sociology professor; Dr. Richard E. Shannon, economics professor; Dr. Arnold W. Bolle, dean of the UM School of Forestry; Dr. Harold Tascher, professor of social welfare; Larry Barsness, director of composition; Dr. Thomas Payne, political science professor, and Dr. R. Wayne Pace, speech communication chairman.

Classes meet in UC suite 360, rooms B,C,D and E during the leadership program.

Several hundred persons from throughout the nation have been graduated from the SAL program since the program was launched on the Missoula campus in 1940. Classes now are under the direction of Dr. James F. Hall, coordinator of extension and continuing education at the University.
