ELECTION OF OFFICERS,
DISCUSSION OF ASSETS
SET FOR CU MEETING AT UM

MISSOULA---

Election of three new officers and discussion of financial assets are among the items on the agenda for the 15th annual meeting of the University of Montana Federal Credit Union (MFCU) Thursday night.

James M. Huggins, credit union manager, said three officers are currently completing two-year terms. The dinner meeting is set for 6:30 p.m. in the Five Valleys Room of the University Center.

Keynoting the meeting will be David R. Weinberg of Madison, Wisc., assistant executive managing director of CUNA International Inc., formerly the Credit Union National Association.

MFCU officers completing two-year terms include Dr. Ludvig G. Browman, zoology professor, first vice-president; Robert L. Clark, physical plant warehouse foreman, second vice-president, and Fred A. Henningsen, accounting and finance professor, treasurer.

Slated to complete another year as credit union officers are Dr. Richard E. Shannon, economics professor, president; Edgar F. Niethold, assistant to the UM food services director, secretary; Jesse K. Dove, director of nonacademic personnel, membership officer, and Dr. Gardner Cromwell, law professor, MFCU director and board member.

Twenty-eight out-of-town guests who are members of other credit union organizations in Montana are slated to attend Thursday's meeting.

Mrs. La-Verne Harbrige, MFCU office manager, said 325 members and potential members are expected for the meeting, including husbands, wives and children of current MFCU members.

Before his appointment as executive assistant managing director of CUNA International Inc. in August 1964, Weinberg served as director of the organization's legal and legislative department and the CUNA Washington, D.C., office.
