ADMINISTRATORS ASSUME DUTIES
AT UNIVERSITY OF MONTANA

MISSOULA--

Dr. William G. Craig, Dr. Rudyard B. Goode and Dr. Richard A. Solberg assumed the duties of UM academic vice-president, dean of the School of Business Administration and acting dean of the College of Arts and Sciences, respectively, this week.

Dr. Craig, who recently moved to Missoula from Ripton, Vt., replaces Dr. Earl C. Lory, who has been acting academic vice-president since September 1967. Dr. Lory returns to the teaching staff in the Department of Chemistry.

Dr. Craig is now acting president in place of UM President Robert T. Pantzer while Pantzer is attending a self-study institute at the University of California in Berkeley. Pantzer will return to UM July 15.

Dr. Craig has been deputy assistant secretary for administration for the U.S. Department of Health, Education and Welfare since 1966. He also is a former Peace Corps training director.

The new UM vice-president also has 18 years of experience as administrator and faculty member in universities in California, Kansas, Washington and Vermont.

Dr. Goode replaces Dr. Donald J. Emblen, who has been acting dean of the School of Business Administration since August 1967. Dr. Goode also will be professor of business at UM. Dr. Emblen will return to full-time teaching.

Dr. Goode is formerly program director for administration, Research Center, and professor of finance, School of Business and Public Administration at the University of Missouri, Columbia.

Dr. Solberg, who has been associate dean of the UM College of Arts and Sciences since July 1967, succeeds Dr. Robert W. Coonrod, who is the new academic vice-president at the University of Idaho. Dr. Solberg still retains his duties as director of the UM Biological Station at Yellow Bay on Flathead Lake.
