50 PREREGISTER FOR TAX INSTITUTE AT U OF MONTANA

MISSOULA---

About 50 lawyers, accountants, insurance agents and trust officers from Montana and other northwest states have preregistered for the University of Montana's annual Institute on Taxation and Estate Planning, to be held Friday and Saturday here.

Registration for the two-day program gets under way at 5:30 p.m. Thursday (Dec. 4) at the Florence Hotel. Formal institute sessions also will be held at the hotel. Registration continues at the hotel at 8:30 a.m. Friday.

Out-of-state speakers slated to participate in the program include Norvie L. Lay, an associate professor of law at the University of Louisville, and Stanfield D. Hill, senior advanced underwriting consultant for Mutual of New York.
