BANKER, ATTORNEYS TO SPEAK DURING UM PROGRAM IN G.F.

MISSOULA

A Havre bank executive and lawyers from Havre, Billings, and New Jerseywill address lawyers, bankers and others attending a one-day legal program March 9 in Great Falls. The program is part of Continuing Legal Education--Montana (CLEM) and is sponsored by the University of Montana School of Law and the Montana Bar Association. Monday's program will be at the Rainbow Hotel in Great Falls.

Half of Monday's program beginning at 9 a.m. will be devoted to the Federal Consumer Protection Act, which is frequently referred to as "Truth in Lending." The remaining half of the program, entitled "Revocable Trust" and beginning at 1:30 p.m., will concern the use of revocable trusts in planning of estates.

Participants will include Theodore R. Lloyd, vice-president of First National Bank, <u>Havre</u>. Lloyd will join Donald J. Rapson, who is with the firm of Lautman, Rapson & Keane, <u>Asbury</u>

Park, N.J., in presenting the Truth-in-Lending session.

Fred J. Weber of Weber, Bosch, Kuhr & Dugdale, Havre, and John M. Dietrich of Crowley, Kilbourne, Haughey, Hanson & Gallagher, Billings, will discuss Revocable Trust.

Registration begins at 8:30 a.m. The Great Falls program was arranged by the Cascade County Bar Association. Joseph R. Marra, <u>Great Falls</u>, is regional chairman of the association.

Robert E. Sullivan, dean of the UM law school, said the CLEM program is designed to take continuing legal education to six Montana cities, rather than scheduling a program in one central location.

Other cities to host the upcoming programs include Billings, March 10; Butte, March 19; and Bozeman, March 20.
