This is a seminar course on the political economy of development aimed at mitigating poverty. No assumptions are made regarding the background of students. However, I do assume that students are willing to work hard and put in the time necessary to read this challenging required text, take careful written notes on the assigned reading, and to come to class prepared to ask questions and discuss the readings assigned for that day. Students are strongly encouraged to read the book and take notes before the program begins and then to re-read the text again and take additional notes as it is assigned during the program. Most students will find the reading quite challenging and there will be many parts of the reading that will require help to understand well. I will be happy to answer questions and to explain the reading but only after students have put in the necessary time to read and take careful notes.
