UM PHARMACY ALUMNI TAKE  
STATE BOARD EXAMINATIONS

MISSOULA--

The 1970 graduates of the University of Montana School of Pharmacy recently took examinations given by the Montana State Board of Pharmacy on the UM campus as a part of their qualifying requirements to become registered pharmacists in the state.

Written examinations covering the major areas of academic instruction were administered by the board, comprised of Earl Eck, Lewistown, president; Lloyd Thomes, Great Falls, vice-president, and William Jess Johnson, Hardin, treasurer. The secretary of the board is John McFarlin of Billings.

Practical examinations were given for full licensure to candidates who completed practical internship training during the past year in pharmacies in Montana and surrounding states.

The class of 1970 will serve internships in approved pharmacies and return to UM in June of 1971 for final practical examinations prior to licensing as registered pharmacists. Twenty-five of the 26 graduates took the examinations during a two-day period.
