**Course Objectives:** It is the purpose to examine the evolution of the major policies directing the allocation, use and management of the major federal lands currently administered by the Forest Service, Park Service and BLM. We will examine:

- how scarcity has affected policy,
- how interagency competition has affected policy,
- the evolution from sustained-yield to sustainability,
- approaches to policy studies of policy models and policy development,
- the evolution of multiple use into ecosystem management,
- the relationship between policy and major federal land ethics,
- the legal status of federal lands and decision-making
- how shifts in policy often reflect dominant socio-economic problems.
