TAX INSTITUTE IN MISSOULA

MISSOULA--

The 1970 Institute on Taxation and Estate Planning, sponsored by the UM Law School, will be held in Missoula Dec. 4-5. Institute sessions will be held in the Bitterroot Room of the Florence Hotel.

This year's institute, designed for lawyers, accountants, insurance underwriters and trust officers, will feature the 1969 Tax Reform Act.

Topics under discussion will include capital gains and losses, income averaging, tax preferences, farm problems, employee problems, charities, depreciation, trusts and corporate problems.

Dr. Richard G. Landini, UM academic vice president, will welcome institute participants at the opening session.

A \$20 registration fee will be charged and covers tuition, speech outlines, and coffee breaks. Registration in advance is encouraged and checks should be made payable to the University of Montana Law School.
