**Course Description:**

This course introduces the student to the workings of the legislative branch of government. The course focuses on understanding the functions of the legislative branch with special attention given to drafting proposed legislation.

**Course Objectives:**

1. To acquire substantive knowledge and understanding of the workings of the legislative branch of government.
2. To develop the skills and abilities to establish working relations with legislators and their staff.

**Required Readings:**

There are required readings for each lesson. The required readings are found under the "Course Materials" icon for this class.

**Course Requirements:**

Lessons must be completed each Wednesday night by 7 pm (MST). Students are required to read the mini-lectures, all assigned readings, participate on the discussion board, and complete all writing assignments by the established times. Lessons provide summary points based on what the instructor is trying to emphasize as key elements for the student to learn and understand. These are not to be considered all-inclusive and the student is responsible for using these summary points in developing their understanding.

All time requirements for discussion board answers, papers, and projects will be based on Mountain Standard Time. The instructor will be online reviewing student responses to discussion board questions each Wednesday night from 7 to 9 pm (MST).

**Writing Assignments**

Five writing assignments are required. The first and second writing assignments are to be three to five page in length, double-spaced. The third writing assignment is your proposed draft legislation and the fourth is your testimony both pro and con. The fifth is a completed fiscal note. Students are required to follow the instructions contained in the relevant lesson for each assignment.

## **Course Grading:**

Grading will be based on your Discussion Board Responses and writing assignments. Each writing assignment is worth 50 points and Discussion Board Responses are worth 100 points for the semester, for a total of 350 points. Discussion Board points will be available at the end of the semester. If you are curious as to how you are doing on your Discussion Board questions during the semester, you may call or email the instructor.
